² Otherwise known as "CARF". Monies go directly to a separate account to be used for major capital assets and course renovations.

Annual golf dues for Oak, Aspen, Intermediate and Corporate memberships include club storage and cleaning, locker, and annual Manitoba Golf Association fees.

There is an annual *share maintenance fee* of \$125.00, including GST. This is billed each November and payment is due by December 31st. This fee serves to keep your share in good standing. A member may take a leave of absence from golf in any year and maintain their shareholder status by ensuring the *share maintenance fee* is paid annually.



MEMBERSHIP APPLICATION PROCESS

- To join Rossmere a *share* must be purchased for \$210.00 (\$200.00 plus 5% GST). This fee must accompany your completed membership application form (attached to this document below). Your application will go to the Rossmere Board of Directors at the next board meeting for approval.
- Upon approval of your application by the Board of Directors, and prior to commencing golfing, there is an initiation or transfer fee of \$1,050.00 (\$1,000 plus GST). This fee can be paid in full or paid in a maximum of 10 annual payments, depending on the membership category selected.
- Rossmere has a Capital Asset Replacement Fund (CARF) and there is an annual contribution obligation included in the annual dues for certain specified membership categories. The Board of Directors has set the CARF rate at 10% of annual golf dues.
- New members that would like to have clubhouse charging privileges must fill out and submit the Member Credit Application form (attached to this document below).

Rossmere Country Club permits members to charge food & beverage purchases and guest green fees providing they complete this application and submit it to the General Manager.

At the end of every month the club prepares monthly statements for members to pick-up at the clubhouse office. Statements not picked-up by the 10th of the month are mailed. The club expects statements to be paid for by the 20th day of each month. Member accounts that are not paid by the 20th will automatically be charged to the members credit card.
