## Group Associate Membership

In an effort to acknowledge the changing times in not only our business and family lives, but our leisure lives as well, Rossmere Country Club is offering a new membership category, the Group Associate Membership. The Group Associate Membership is an excellent alternative for golfers that prefer to have a golfing home, however find their current lifestyle is such that a full-membership is not feasible.

The Group Associate Membership category includes:

- \* Maximum 5 members / minimum 3 members registered
- \* Aspen membership privileges
  - o No playing restrictions on Mondays through Fridays
  - o May not tee off prior to 11:30 a.m. on Saturdays, Sundays and Holidays
  - o May book tee times up to 5 days in advance
- \* No share or initiation fee required.

Members will be allowed to participate in club golf tournaments at the applicable entry fee, plus a golf pass when the event is a "play your own ball format". As well, to participate in a club golf tournament Group Associate Members must register for the Golf Manitoba & RCGA handicap program. Male Group Associate Members may participate in the Club Championship, however, they are not eligible to play in the Championship Flight. Female Group Associate Members are eligible to play in the Ladies Club Championship.

\* Group Associate Membership golf passes will include the individual's name and will be non-transferable. (ie: cannot be redeemed by any other person or guest)

\* Group Associate Membership golf passes are not required to be issued evenly within the group, however, each registered individual within a Group Associate Membership must receive a minimum of 15% of the group's golf passes, and a maximum of 50%.

- \* Two (2) Tiers of the Group Membership category:
  - o Group 100
    - The group will receive 100 Golf Passes for the current season (expire at the end of the year)
    - **Cost: \$3,700.00 & 370.00 CARF & 203.50 GST = \$4,273.50**
  - o Group 50
    - The group will receive 50 Golf Passes for the current season (expire at the end of the year)
    - **Cost: Half of the above = \$2,136.75**

\* Golf passes will be issued upon full payment of the Group Associate Membership.

\* The following services are available to all individuals participating in a Group Associate Membership: Club Storage & Cleaning (\$114); Locker (\$25) and Golf Manitoba/RCGA Handicap Program (\$25) all tax included.

\* The Group Associate Membership category will be reviewed annually by the Board of Directors, as all Rossmere membership categories are.

### Member Credit Application

Rossmere Country Club permits members to charge food & beverage purchases and guest green fees providing they complete this application and submit it to the General Manager.

At the end of every month the club prepares monthly statements for members to pick-up at the clubhouse office. Statements not picked-up by the 10<sup>th</sup> of the month are mailed. The club expects statements to be paid for by the 20th day of each month. Member accounts that are not paid by the 20th will automatically be charged to the members credit card.
