### Member Credit Application

Rossmere Country Club permits members to charge food & beverage purchases and guest green fees providing they complete this application and submit it to the General Manager.

At the end of every month the club prepares monthly statements for members to pick-up at the clubhouse office. Statements not picked-up by the 10<sup>th</sup> of the month are mailed. The club expects statements to be paid for by the 20th day of each month. Member accounts that are not paid by the 20th will automatically be charged to the members credit card.
